1 **REGISTRATION**

- 1.1 The Dulux London Revolution Trails ("Event") consists of an event on foot through the Chiltern Hills and along the Thames Path scheduled to take place on 9th May 2020 and is organised by Threshold Sports Ltd ("Threshold") and shall be referred to as the "Dulux London Revolution Trails" or such other title as Threshold may advise.
- 1.2 Only persons aged 16 years or above as at 9th May 2020 may register for the Event. Persons under the age of 18 years must be accompanied by a parent or guardian. If the nominated parent or guardian cancels their entry before the Event, withdraws or is disqualified during the Event, the Participant under the age of 18 will also be unable to continue.
- 1.3 Applicants must complete and submit the online registration form ("Online Registration Form") which can be found at <u>www.trails.london-revolution.com</u> (the "Event Website"), and pay the registration fee (the "Registration Fee") and the booking fee (the "Booking Fee").
- 1.4 All successful applicants (hereinafter referred to as "Participants") will be notified by way of an email confirmation that they have been allocated a place to take part in the Event ("Online Confirmation").
- 1.5 Places in the Event are strictly limited and therefore applications are subject to availability. Subject to Clauses 1.2 to 1.4 (inclusive) above, Threshold will consider applications on a first come, first served basis by eligible Participants (which Threshold shall determine in its absolute discretion) and otherwise in accordance with these Rules and Regulations ("Rules and Regulations").
- 1.6 The relevant date for registrations shall be the date the Participant receives the Online Confirmation. Threshold is not responsible for technical, hardware or software failures of any kind, lost or unavailable network connections, or failed, incomplete, garbled or delayed computer/Internet transmissions or other errors or malfunctions of any kind which may prevent receipt by Threshold of an Online Registration Form or receipt by an applicant of an Online Confirmation. For the avoidance of doubt, if, for any reason whatsoever, an applicant does not receive an Online Confirmation, said applicant shall not be considered to be a Particpant and Threshold shall not be responsible for the applicant's failed application.
- 1.7 All Online Registration Forms must be received by Threshold on or before midnight on Sunday 3rd May 2020 ("Entry Deadline"). Any Online Registration received by Threshold after the Entry Deadline will not be accepted. This deadline is subject to change if the Event entries are full prior to the above date, and in accordance with Clause 1.5. Threshold reserves the right to close the Online Registration Form at any point.

- 1.8 Subject to the other provisions of this Clause 1, submission of the Online Registration Form, payment of the Registration Fee and the Booking Fee, and receipt of the Online Confirmation shall (together) entitle the Participant to participate in the Event.
- 1.9 The Event is personal to the Participant accepting these Rules and Regulations, and the Participant undertakes and agrees (i) only to participate in the Event wearing the number assigned to his/her registration, (ii) not to authorise or permit any third party to use his/her Participant number for the Event and (iii) not to sell, transfer or give any other person the right to participate in the Event and/or use the Participant's number, with the exception of compliance with Clause 2.2.
- 1.10 If at any time it is discovered that any Participant should have been ineligible to participate in the Event or if participation in the Event should have been refused for any reason whatsoever, Threshold reserves the right to disqualify such Participant from/refuse such Participant entry to the Event. Further, Threshold reserves the right to reject at any time any Online Registration Form which it believes to be fraudulent, or to disqualify at any time any Participant it believes not to have fully complied with these Rules and Regulations from participating in the Event, or in any future Threshold events. Threshold shall not be liable in any way to such Participant as a result of any such disqualification or refusal. It is the Participant's responsibility to ensure full compliance with these Rules and Regulations.
- 1.11 If any provision in these Rules and Regulations, whether in full or in part, is held to be invalid or unenforceable, all other remaining provisions (in full or in part) shall continue to be valid and enforceable.
- 1.12 These Rules and Regulations (and any documents referred to herein) constitue the entire agreement and understanding of the parties and supersede any previous agreement between the parties relating to the Event. Nothing in these conditions shall constitute or be deemed to constitute a partnership between the parties. These Rules and Regulations shall be interpreted in accordance with the laws of England and Wales and any dispute rising hereunder shall be subject to the exclusive jurisdiction of the English courts.

2 CANCELLATION OPTIONS

- 2.1 Any Participant intending to cancel their place in the Event shall inform Threshold as soon as reasonably practicable ("Cancellation Notification").
 - Threshold operates a seven (7) day cooling off period. Accordingly, the Participant is entitled to cancel his/her Entry to participate provided Threshold receives written notice of cancellation within seven (7) days of payment of the Registration Fee. During this 7 day period the Participant is able to cancel his/her entry and receive a full refund of the

Registration Fee by emailing info@londonrevolution.com. The notice must be received before the end of the seven (7) day cooling off period.

- Thereafter, the Registration Fee is non-refundable under any circumstances and is due as outlined below, on submission of the Online Registration Form. If payment is rejected or not cleared for whatever reason, Threshold reserves the right to refuse registration and entry into the Event.
- 2.2 A Participant can transfer their entry to another individual ("Participant Transfer") if notice is given to the Event Organisers.
 - Notice of a Participant Transfer must be done via the Participant's <u>MyEvents</u> Portal.
 - Click Transfer registration to another athlete
 - Enter recipient email address in email address field
 - Enter recipient email address in Confirm email address field and click Submit
 - Confirmation email sent verifying transfer process initiated to transferring participant and to a new participant
 - The deadlines and associated administration fee for this are:
 - Before 23:59, 3rd May 2020: £25
 - Transfers may only be completed into the same category
 - The most current Registration Fee and Booking Fee is applied at checkout when the recipient accepts the transfer. This could be higher than that for the original participant

3 THE DULUX LONDON REVOLUTION TRAILS

- 3.1 Subject to Clause 3.3 below, the Event will be held on 9th May 2020.
- 3.2 The Event is a one day endurance event on foot through the Chiltern Hills and along the Thames Path, totalling up to 50km~ ("Event Distance"). Participants are able to enter the following packages:
 - "Ultra marathon": Run/walk 51.8km only
 - "Marathon": Run/walk 43.4km only
 - "Half marathon": Run/walk 22.1km only
 - All participants have the option to add on "All Inclusive Camping" with massage, dinner and breakfast included on the Online Registration Form.
- 3.3 Prizes will be awarded to individuals taking part in all packages based on 'gun time'. These will be for the fastest female and male in each category. For those competing for a prize, they must set-off in the following waves:
 - "Half marathon": Wave D
 - "Marathon": Wave B
 - "Ultra Marathon": Wave B
- 3.4 Threshold reserves the right to change the time, date, route and/or format of the Event and to cancel the Event, in whole or in part, without notice or liability to the Participant. Threshold shall inform the Participant by email of any such change or cancellation.
- 3.5 Threshold reserves the right to remove any Participant from the Event, either during or before it, due to ill health, or any other reason (at Threshold's discretion) that may render him/her unfit to safely complete the Event. The Participant confirms that he/she will not take part in the Event if he/she is suffering from any contagious illness (in particular diarrhoea or vomiting symptoms) and confirms that he/she will report any illness during the Event, to the Event medical team immediately.
- 3.6 Without prejudice to Threshold's right to remove any Participant from the Event due to ill health pursuant to Clause 3.4 above, the Participant acknowledges and agrees that:
 - If he/she is a participant with 'All Inclusive Camping' and becomes ill with a non-infectious illness (as determined by the Event medical team) but wishes to sleep in the overnnight basecamp, Threshold will, where reasonably practicable and subject to the advice of the Event medical team, transfer him/her to the overnight basecamp. Where such transfer is not reasonably practicable (or where the Event medical team advise against the Participant's

continued involvement in the Event), the Participant shall be removed from the Event.

- 2.8.2 If, however, he/she becomes ill with an infectious illness (as determined by the Event medical team), the Participant shall be removed from the Event.
- 3.7 A Participant may be disqualified ("Disqualification") from the Event by Threshold if:
 - he/she arrives at the pit stop after the designated pit stop cut off time ("Pit Stop Cut Off Time"). He/she will be responsible for his/ her repatriation according to Clause 3.7; Pit Stop Cut Off Times will be communicated to the Participants via e-mail a minimum of two weeks in advance of the Event;
- 3.8 In the event of a Participant having to leave the Event because of injury, illness, voluntary withdrawal or Disqualification, he/she will be responsible for all repatriation travel costs and related incurred travel arrangements. This includes repatriation from the overnight base camp or pit stops to the finish location as a result of voluntary withdrawal or Disqualification. Threshold will not be responsible for transporting the Participant or any belongings of the Participants, including, but not limited to, their bag.
- 3.9 Threshold will endeavour to provide every Participant with a completion time but is not responsible for any electronic timing anomalies.
- 3.10 No drugs, illegal substances, performance enhancing substances or intoxicants of any kind are permitted to be used by any Participant either before or during participation in the Event. Threshold reserves the right to refuse attendance at, or participation in, the Event by any persons found to have consumed or to have in their possession any drugs, illegal substances, performance enhancing substances or intoxicants of any kind.
- 3.11 Threshold reserves the exclusive right and license throughout the world (and Participant hereby grants Threshold such exclusive right and licence) to interview and/or photograph and/or film the Participant at the Event (and before and after the Event as Threshold may reasonably require) and to the unlimited, worldwide, sub-licensable right to record, film, reproduce and use in all current and future media (including without limitation, print, audio, visual, audio-visual, virtual media, the Internet, mobile telephony and so-called "3-G" technologies, CD-ROM or DVDs) the Participant's name, likeness and image or facsimile image, signature, voice, video and film portrayals and other means of identification of the Participant, and any biographical or other information or data related to the Participant (including ride times and results), in connection with the production, advertisement, marketing, promotion or sale of Event sponsor products and/or the promotion, marketing or advertisement of Threshold or any Event sponsor or partner.
- 3.12 As a continuing condition of entry each Participant shall ensure that, for the duration of the Event:
 - he/she understands that the event involves sustained physical exercise in a remote area;
 - he/she carries a charged mobile phone with appropriate credit;
 - he/she accepts that they are responsible for their own safety during the Event;

- he/she must be competent in navigating from a map of the route provided by Threshold Sports. The route will be signposted, however, he/she remains responsible for navigating themselves from the start to the finish;
- he/she agrees that they are responsible for their own fitness to take part in the Event, and will consult a doctor prior to the Event if necessary;
- he/she does not start earlier than the official start time of the Event. Failure to comply with this rule will result in disqualification;
- if taking part in "Ultra", "Full" or "Half", he/she completes the route between the hours of 8.30am and 9pm on Saturday 9th, however, Threshold reserves the right to alter the route start and finish times in the event of mitigating circumstances e.g. inclement weather conditions;
- he/she acknowledges that it is their responsibility to ensure that they have been correctly checked-in at each checkpoint along the route;
- he/she acknowledges the recommended kit list of the Event, in accordance with their Event package, as communicated by email prior to the Event by Threshold Sports;
- he/she understands that if they wish to withdraw from the Event, they must report to the nearest pit stop or contact Event Control;
- he/she understands they may not be transported by vehicle along any portion of the trail or between any points on it, unless they have formally withdrawn from the Event;
- due to the outdoor nature and endurance aspect of the Event, he/she maintains personal hygiene at all times, and adheres to all hygiene advice provided by Threshold;
- he/she displays the official event numbers provided in the manner indicated during the Event;
- he/she follows the Event route signage at all times, and does not deviate from the official signed route of the Event;
- he/she abides by all Event Rules and Regulations;
- he/she complies with the Countryside Code at all times;
- he/she is responsible for the collection and appropriate disposal of his/her litter along the entirety of the route, at the pit stops, and at the overnight base camp;
- he/she understands that there is no permittance of a formal support crew for any Participant along the route, as this could endanger the safety of Participants or other Event staff; and
- he/she obeys traffic officers and authorised marshals at all times; failure to do so will result in disqualification.

4 PARTICIPANT'S WARRANTIES AND UNDERTAKINGS

- 4.1 The Participant acknowledges that participation in the Event is not possible without validly entering into this agreement on these Rules and Regulations and agrees to be bound by these Rules and Regulations.
- 4.2 The Participant agrees at all times during the Event to abide by the reasonable instructions and guidelines of Threshold's staff, nominated representatives, and contractors and to behave appropriately at all times on the route and in the overnight base camp. Participants acknowledge and agree that Threshold will organise and run the Event and will have sole authority and be the final arbiter on all decisions relating to the following aspects of the Event: health and safety, logistical operations, participation, organisation and Rules and Regulations.
- 4.3 The Participant understands the endurance demands of the Event and commits to preparing to take part in the Event by:
 - complying with the Event training advice as issued by Threshold;
 - completing a medical and dietary form as provided by Threshold prior to the Event;
 - providing emergency medical contact details of someone who is not also participating in the event;
 - confirming that he/she has appropriate liability and equipment insurance in place in order to participate in the Event and acknowledges that he/she has no claim against Threshold in relation to the provsion of such insurance.
- 4.4 The Participant acknowledges that participation in the Event involves inherent risks of accidents and injury.
- 4.5 The Participant acknowledges that he/she is personally responsible for his/her own belongings during the Event, and that he/she must collect any personal lost items from lost property before he/she leaves the Event.
- 4.6 Participation in the Event is at the Participant's own risk. The Participant irrevocably agrees to hold harmless, indemnify and reimburse Threshold from and for any sum, costs or expenses (including legal and professional fees) incurred, payable or paid by Threshold to any person (including the Participant and/or any of the Participant's insurers) in connection with any accident, loss, damage or injury (including death) arising out of the Participant's attendance at and participation in the Event or any part thereof (except where any such injury or death is caused by the negligence of Threshold or any of its employees).
- 4.7 The Participant confirms without reservation that he/she is in a good physical condition to participate in the Event, that he/she understands the endurance demands of the Event, and will not arrive at the Event in ill health or unfit to take part.
- 4.8 The Participant confirms that he/she will not publish or post on any website or other media operated by Threshold or related to the Event any text, statement, photograph, image or other material which is obscene, blasphemous, defamatory, infringes the intellectual property or other legal rights of any third party or is otherwise unlawful, offensive or inappropriate. Threshold will have the right to remove any material at its

discretion and take appropriate legal action against any person found to be or alleged to be in breach of this Clause 4.8.

4.9 The Participant's journeys to and from the start and finish lines of the Event each day shall be entirely at his/her own risk and cost. Threshold will not be responsible for transporting the Participant or any belongings of the Participants, including, but not limited to, their bag.

Event administration
